Contract will be awarded to the lowest bidder provided he/she furnishes satisfactory evidence of the ability to perform or to furnish satisfactory services called for.

Bids to be forwarded by U.S. Mail should be mailed a sufficient number of working days prior to the scheduled proposal opening date to assure delivery in time for the bid opening. Bids received after 1:00p.m. On Friday, March 12,2021 will be returned to the bidder unopened. Bids are to be prepared at no cost to the Kingston K-14 School District and will remain the District's property. Bids must be delivered sealed and marked, "Gasoline Bid".

The Board reserves the right to reject any or all bids or any part of any bid and accept that bid which appears to be in the best interest of the school district. The board reserves the right to waive any informalities in any bid. Any bid may be withdrawn prior to the scheduled time for the opening of bids. The District has the right to accept the bid it considers most advantageous.
